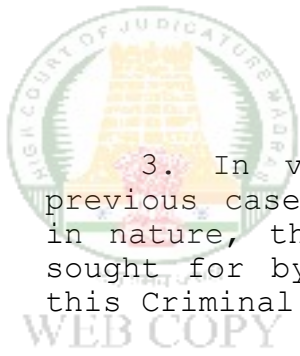

Vide Order dated 20.05.2021, this Court had enlarged the petitioner on bail on certain conditions. This petition has been filed by the petitioner seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondent submits that the petitioner has eight previous cases pending which are similar in nature. However, it is submitted that the petitioner is complying with the conditions.



3. In view of the above submission, considering that eight previous cases are pending against the petitioner which are similar in nature, this Court is of the considered view that the prayer as sought for by the petitioner could not be acceded to. Accordingly, this Criminal Miscellaneous Petition is dismissed.
