ORDER

This petition has been filed seeking a direction to direct the Special Court for Trial of Cases Registered under SC/ST (Poa) Act, Tiruvannamalai, to consider the bail application of the petitioners in Crime No:12/2021, on the file of the 2nd respondent, on the same day when they surrenders before the said Court in the said Crime Number.

2. In view of the amendments made in the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989, this Court is of the view that the usual directions that were issued by this Court cannot be issued routinely in all cases. Therefore, the petitioners are directed to surrender before the trial Court within a period of two weeks from the



date of receipt of a copy of this order or after commencement of normal functioning of the Court, which ever is later and on such surrender, the the Special Court for Trial of Cases Registered under SC/ST (Poa) Act, Tiruvannamalai, shall deal with the matter on the same day on merits and in accordance with law, after issuing notice to the victims under Section 15-A (3) of the SC/ST Act.

3. This Criminal Original Petition is disposed of with the above directions.
