**Prayer:** Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus directing the respondents or anyone claiming through or under them, to strictly comply with Regulation 6(b) of the Tamil nadu Electricity Supply Code, 2004, in respect of demand charges during the periods of lock down and restricted functioning imposed by the Governments and authorities and to further refrain from levying, demanding
