2.While filing the petition, they had shown the Inspector of Police, Thirumangalam, Chennai City, as the first respondent. Thereafter, it was represented by the learned Additional Public Prosecutor that the case has been transferred to the Inspector of Police, R2 Kodambakkam Police Station, Kodambakkam, Chennai City. Hence, this present amendment petition has been filed.

3.It is further represented that now the complaint has been again transferred to the file of the Inspector of Police, R3, Ashok Nagar Police Station, Ashok Nagar, Chennai City, on the point of jurisdiction. In view of the same, the criminal Miscellaneous petition in CrI.MP.No.9387 of 2021 is dismissed as infructuous.

4.This Court, directs the petitioners to file a fresh miscellaneous petition arraying the Inspector of Police, R3, Ashok Nagar Police Station, Ashok Nagar, Chennai City, as the first respondent in the CrI.OP.No.15245 of 2021.
