3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

4. Accordingly, the condition insofar as appearance as imposed by order dated 06.08.2021 alone stands modified and the petitioner should appear before the respondent police on every Monday at 10.30.a.m. till the filing of charge sheet. All other conditions remain unaltered.
