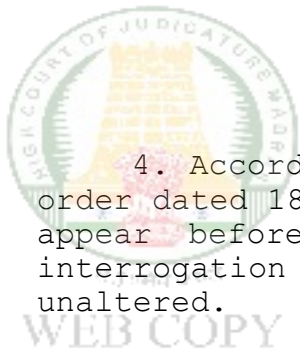

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.

4. Accordingly, the condition insofar as appearance as imposed by order dated 18.08.2021 alone stands modified and the petitioner shall appear before the respondent police as and when required for interrogation on receipt of summons. All other conditions remain unaltered.
