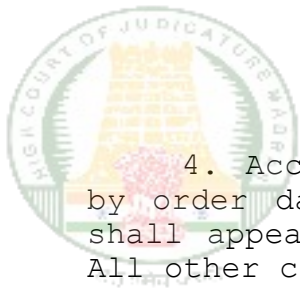

Vide Order dated 17.06.2021, this Court had enlarged the petitioner on bail on certain conditions. This petition has been filed by the petitioner seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the charge sheet has been filed.

3. In view of the above submission, this Court is of the considered view that the prayer sought for by the petitioner could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed by order dated 17.06.2021 alone stands modified and the petitioner shall appear before the trial Court on each and every hearing date. All other conditions remain unaltered.
