3.The contentions put forward by the learned counsel appearing on behalf of the petitioners are purely factual in nature and this Court cannot venture into conducting a mini investigation into the matter and it therefore does not fall within the ambit of its jurisdiction under Section 482 of Cr.P.C. Any finding on facts will also have a bearing on the investigation conducted by the 1st respondent Police. It is also seen from records that the 1st respondent police is investigating the case and counter in Crime Nos.485 and 486 of 2021.

4.In the facts and circumstances of the case, this Court is not inclined to interfere with the investigation conducted by the 1st respondent Police at this stage.

In the result, this Criminal Original Petition is dismissed and the 1st respondent Police is directed to follow Police Standing Order 566 and proceed further with the investigation in accordance with law and complete the investigation and file a final report or a closure report, as the case may be. Consequently, connected miscellaneous petition is closed.
