Today, when the matter came up for hearing, the learned Additional Government Pleader appearing for the respondents reiterating the averments made in the counter affidavit filed by the third respondent, submitted that subsequent to the filing of this writ petition, the pension of the writ petitioner was revised and the petitioner is drawing pension at Rs.6800/- from 01.10.2007 and at Rs.6850/- from 01.08.2020 and hence, nothing survives for adjudication.
