V. Aaditiya J. Garg & another (Civil Appeal No.4085 of 2020
dated 17.12.2020).

2. Thus, the petitioner is permitted to file statutory appeals and such appeals, if filed, within a period of three (3) weeks from today, shall be received by the registry of the first appellate authority without reference to limitation, but subject to all other compliances including pre-deposit and shall be disposed, after hearing the petitioner and in accordance with law.

3. These writ petitions are disposed. Connected miscellaneous petitions are closed. No costs.
