COMMON ORDER

[Order of the Court was made by M.M.SUNDRESH,J.]

Alleging that the order dated 11.06.2018 made in W.P.No.3021 of 2018 has not been complied with, the present contempt petition has been filed, while the writ petition challenges the proceedings of the 5th respondent in the writ petition dated 04.03.2020 refusing to accord building permission.

2. It appears that an order has already been passed on 04.03.2020 by the 5th respondent in the writ petition refusing to accord building permission in purported compliance of the order under contempt petition and same has been put into challenge in W.P.No.13936 of 2020.
