In view of the same, the petitioner shall carry a representation to the Joint Commissioner, Animal Husbandry, Dharmapuri District, within a period of two weeks from date and the said authority on receipt of the representation shall deal with the same on merits and in accordance with law, and after following the prescribed procedure and hearing the parties concerned, shall pass a reasoned order and communicate the decision taken to all parties concerned, under acknowledgment, within a period of three months from the date of receipt of representation. No view is expressed herein as regards the merits of or tenability of the petitioner's representation.

3. W.P.No.20170 of 2021 is disposed of. There will be no order as to costs.
