Vide order dated 12.08.2021 this Court had granted anticipatory bail on certain conditions and in one of the condition, the petitioner was directed to appear before the respondent Police daily at 10.30 a.m until further orders.

2. This petition have been filed seeking relaxation of the said condition.

3. Learned Addl. Public Prosecutor appearing for the respondents, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed by order dated 12.08.2021 alone stands modified and the petitioner shall appear before the respondent police, once in 15 days (i.e.,) every first Monday and third Monday at 10.30 a.m. till the investigation is completed and charge sheet is filed and thereafter, shall appear before the concerned trial Court on each and every date of hearing. All other conditions remain unaltered.
