2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that two previous case pending against the petitioner. However, the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 16.07.2021 alone stands modified and the petitioner is directed to appear before the respondent police every Monday and Friday at 10.30 a.m., till filing charge sheet and thereafter as and when required. All other conditions remain unaltered.
