The petitioner, who apprehends arrest at the hands of the respondent police for the offence punishable under **Sections 8(c), 20 (b) (ii) (A) of NDPS Act**, in Crime No.875 of 2019 on the file of the respondent police, seeks anticipatory bail.

2. On earlier occasion, this Court had directed the respondent to file a report whether the contraband involved in this case is a commercial quantity or not.

5. In view of the above that the investigation has been completed and the final report has been filed and it has been taken on file in C.C.No.4779 of 2020 on the file of the V Metropolitan Magistrate, Egmore, Chennai, this petition has become infructuous.

6. Accordingly, this Criminal Original Petition stands dismissed.
