Petition filed under Article 226 of the Constitution of India to issue a Writ of certiorarified Mandamus, to call for the records of the third respondent relating to Po.Na.Ka.Mn.9075/A1/2012-1 dated 11.07.2014 to quash the same and to issue consequential direction to the respondents; to grant the scale of the petitioner as per one man commission recommendation and Rs.950-1500 as per V pay Commission Recommendation from 21.05.1990 the date of his appointment as Helper (Electrical); to promote the petitioner as Electrician, Grade I, with effect from 23.11.1992 in the scale of pay of Rs.1200-2040 and to refix his pay from time to time as per successive Pay commission's recommendation; to disburse the consequential monetary benefits with 18% interest per annum. (prayer amended as per order dated 10/12/2014 in MP.No.1/2014 in Wp.17978/2014)
