The learned counsel submitted that after the local body elections are over, the process will once again be taken up and it will be completed in line with the earlier order passed by this Court in W.P.No.16461 of 2021 dated 09.08.2021.

4. Recording the submission made by the learned Government counsel, this writ petition is disposed of. No costs.
