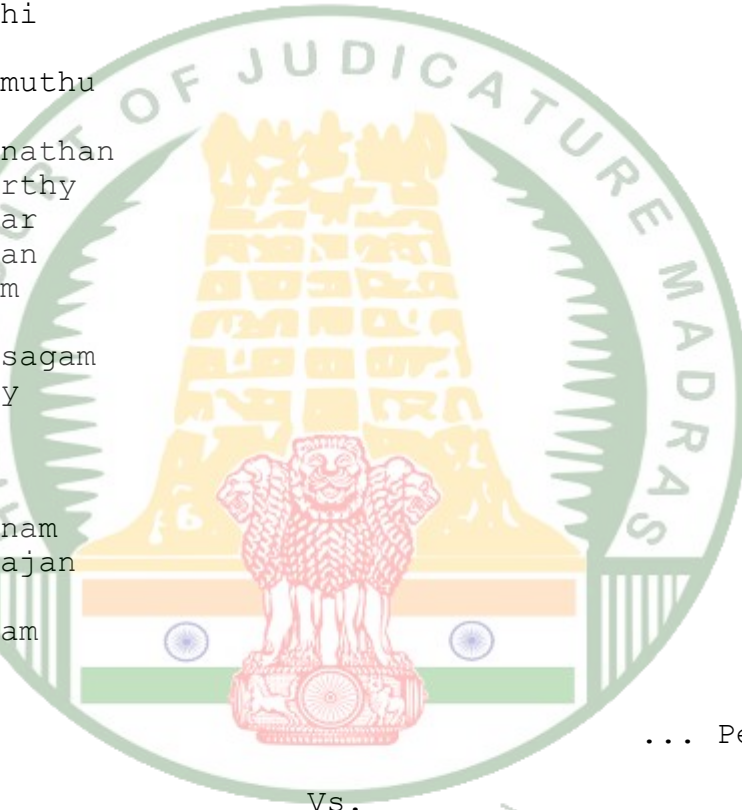

No.211, Handlooms, Handicrafts, Textiles & Khadi Department, dated 29.10.2014 and G.O.(Ms) No.27, Handlooms, Handicrafts, Textiles & Khadi Department, dated 10.02.2015.

3. In view of the above said submission made by the learned Additional Government Pleader appearing for the respondents, this Court is of the opinion that nothing survives for adjudication.
