O R D E R

The relief sought in this writ petition is to issue a mandamus directing the third respondent to issue registration certificate to the Trust as per section 34 (3) of the Juvenile Justice Care and Protection of Children Act, 2000 as amended in 2006 by considering the application dated 03.02.2012.

2. On 19.07.2021, when the matter was taken up for consideration, there was no representation for the petitioner either in person or through the learned counsel and hence, the same was directed to be posted on 26.07.2021 under the caption 'for dismissal'.
