In reply, learned Special Government Pleader (Co-op.) appearing for the contemnors submitted that the Common Order of this Court made in W.P.No.20173/2012 dated 29.08.2019 has already been complied with. However, he stated that in view of the fact that the election code of conduct is in force, four weeks time may be granted to issue a separate posting orders to the petitioners in the promoted post.

4. Recording the same, four weeks time is granted to the respondents to issue separate posting orders to the petitioners in the promoted post.
