ORDER : The Court Made the following order :-

The petitioner, who was arrested and remanded to judicial custody on 23.07.2021 for the offence punishable under Sections 341, 294(b), 336, 397 and 506(2) of IPC, in Crime No.770 of 2021 on the file of the respondent police, seeks bail.

2. This is the second bail application filed before this Court. The case of the prosecution is that the petitioner had robbed a sum of Rs.650/- at knife point from the defacto complainant and also threatened him. Hence, the complaint.

3.The learned counsel appearing for the petitioner submitted that the petitioner has not committed any offence as alleged by the prosecution and he has been falsely implicated in this case. He further submitted that the petitioner has been in jail from 23.07.2021. Hence, he prays for grant of bail to the petitioner.



4. The learned Government Advocate (Crl. Side) submitted that there are seven previous cases pending against the petitioner and earlier bail application was dismissed by this Court in Crl.O.P.No.16323 of 2021 dated 08.09.2021 and there is no change of circumstances and he is a history sheeter. Hence, he vehemently opposed for grant of bail to the petitioner.

5. Considering the facts and circumstances of the case and also the fact that there are seven previous cases pending against the petitioner and earlier bail application was dismissed by this Court and there is no change of circumstances and he is a history sheeter, this Court is not inclined to grant bail to the petitioner.

6. Accordingly, this Criminal Original Petition is dismissed.
