Vide Order dated 31.08.2021, this Court had enlarged the petitioner on bail on certain conditions. This petition has been filed by the petitioner seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 31.08.2021 alone stands modified and the petitioner should appear before the respondent police on 1st and 15th of every month till the filing of charge sheet and thereafter on every hearing date. All other conditions remain unaltered.
