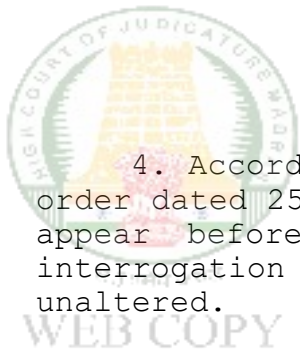

4. Accordingly, the condition insofar as appearance as imposed by order dated 25.08.2021 alone stands modified and the petitioner shall appear before the respondent police as and when required for interrogation on receipt of summons. All other conditions remain unaltered.
