Accordingly, the condition insofar as appearance as imposed by order dated 16.06.2021 alone stands modified and the petitioners shall appear before the respondent police on every Monday at 10.30 a.m., till filing charge sheet, thereafter, before the trial court on each and every hearing date until further orders. All other conditions remain unaltered.
