COMMON ORDER

3. All the writ petitioners submitted their respective applications for issuance of Patta for their respective portion of land which is in their possession and enjoyment. On receipt of the same, the third respondent issued summons to all the petitioners and the enquiry is under progress.

Considering the above, the third respondent is directed to complete the enquiry and pass orders on their respective petitions, after giving them an opportunity of hearing and pass orders on merits and in accordance with law within a period of twelve weeks from the date of receipt of a copy of this order.

5. With the above direction, all the writ petitions are disposed of. There shall be no order as to costs.
