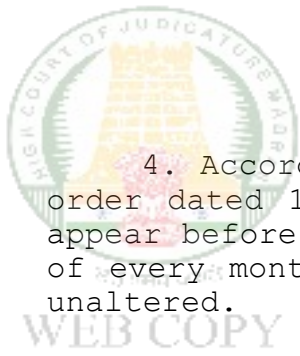

Order: This petition coming on for orders upon perusing the petition and upon hearing the arguments of M/S.M.TAMIL THENDRAL ARASU, Advocate for the Petitioner and of MR. A.GOPINATH, Govt. Advocate (Crl. Side) on behalf of the Respondent the court made the following order:-

Vide order dated 14.09.2021, this Court had enlarged the petitioner on bail on certain conditions. This petition has been filed by the petitioner seeking relaxation of the condition with regard to the appearance of the petitioner before the respondent police.

2. Learned Addl. Public Prosecutor appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed by order dated 14.09.2021 alone stands relaxed and the petitioner shall appear before the vellore town police station on the first working day of every month till filing charge sheet. All other conditions remain unaltered.
