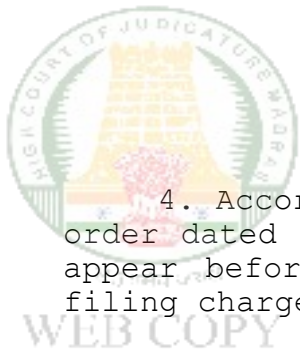

4. Accordingly, the condition insofar as appearance as imposed by order dated 02.09.2021 alone stands modified and the petitioner shall appear before the respondent police every Monday at 10.30 a.m till filing charge sheet. All other conditions remain unaltered.
