2. Learned Addl. Public Prosecutor appearing for the respondents, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 12.08.2021 alone stands relaxed and the petitioner shall appear before learned Judicial Magistrate, Additional Mahila Court, Chengalpattu on the first working day of every month until further orders.. All other conditions remain unaltered.
