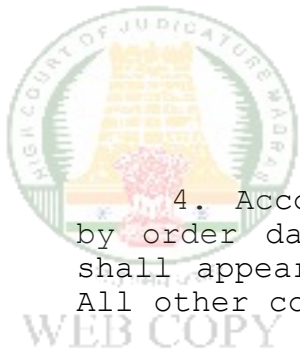

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the charge sheet has been filed.

3. In view of the above submission, this Court is of the considered view that the prayer sought for by the petitioner could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed by order dated 01.07.2021 alone stands modified and the petitioner shall appear before the trial Court on each and every hearing date. All other conditions remain unaltered.
