While passing such order on the aforesaid representation of the petitioner, the respondent shall also consider various orders passed by this Court which has been referred in the aforesaid representation of the petitioner **(*)and** such exercise shall be carried out by the respondents within a period of 12 weeks from the date of receipt of a copy of this order. **(*)The respondent shall consider order dated 17.09.2021 as modified by an order dated 02.11.2021 in W.P.No.19802 of 2021 while passing such order.** Liberty is also given to the petitioner to file an additional representation, if any, within a period of 4 weeks from the date of receipt of a copy of this order. No costs.
