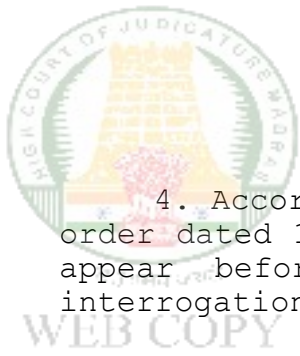

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.
