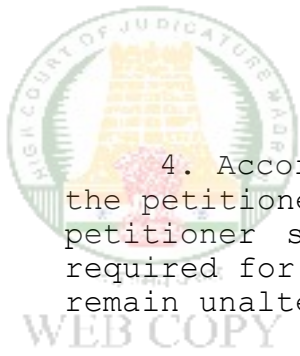

Vide Order dated 18.02.2021 in Crl.MP.No.1654 of 2021 in Crl.OP.No.19435 of 2020, this Court has already modified the conditions imposed on the petitioner. This petition has been filed by the petitioner seeking further relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioner has been complying with the conditions without fail.
