3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.

Accordingly, the condition insofar as appearance as imposed by order dated 23.08.2021 alone stands relaxed and the petitioner shall appear before the respondent police as and when required for interrogation and before the trial court on each and every hearing date until further orders. All other conditions remain unaltered.
