Vide order dated 19.08.2021, this Court had enlarged the petitioner on bail on certain conditions. This petition has been filed by the petitioner seeking relaxation of the condition with regard to the appearance.

2. Learned Government Advocate appearing for the respondents, on instruction, submits that the petitioner has been complying with the conditions without fail.

3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioner could be acceded to.



4. Accordingly, the condition insofar as appearance as imposed by order dated 19.08.2021 alone stands modified and the 1st petitioner shall appear before the respondent police as and when required whereas the other petitioners shall appear before the respondent police on every Monday at 10.30 a.m till filing charge sheet and thereafter as and when required. All other conditions remain unaltered.
