He would further submit that the petitioner has also given a complaint before the 3rd respondent and he wants the 3rd respondent to consider the same while investigating the case in Crime No.209 of 2019.

4.The learned Addl. Public Prosecutor appearing for the respondents in reply to the said submission, stated that the 3rd respondent will take into consideration the version given by both the sides and will file a final report within the time period stipulated by this Court.

5.In view of the above, the 3rd respondent police is directed to either file a final report or closure report, as the case may be, within a period of three months from the date of receipt of a copy of this order under due intimation to the defacto complainant.

6.With the above direction, this Criminal Original Petition is disposed of.
