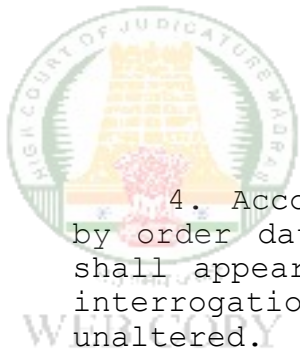

3. In view of the above submission, this Court is of the considered view that the prayer sought for by the petitioners could be acceded to.
