He further submitted that since final report has been filed, the petitioner may be directed to appear before the Special Court for CBI cases, Coimbatore viz., II Additional District Judge, Coimbatore and execute a Bond under Section 88 of Cr.P.C with an undertaking that he will appear before the Special Court for CBI Cases, Coimbatore regularly on all hearing.

Recording the said submissions made by the learned Special Public Prosecutor for CBI cases, the petitioner is directed to appear before the concerned Special Court for CBI Cases, Coimbatore viz., II Additional Judge,, Coimbatore and execute a bond under Section 88 of the Cr.P.C within a period of one week from the date of receipt of a copy of this order.

5. This Criminal Original Petition is closed accordingly.
