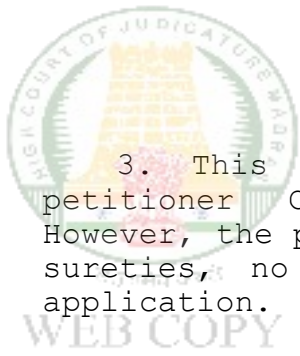

PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offence under Sections 353, 332, 307, IPC r/w 25(1)(b)(a) 27, Indian Arms Act, in Crime No.183 of 2020, on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that while the defacto complainant and his team had conducted vehicle check up to prevent the forest offence, they have seen that the accused coming in a two wheeler with a country weapon, the defacto complainant and his team attempted to apprehend them. At that time, the accused had threatened them and fired them with the country gun resulting in which, the defaco complainant sustained simple injury. Thereafter when the defacto complainant and others have attempted to catch them and in the said attempt, the petitioners fell down and sustained injuries. Based on the complaint, a case has been registered.. Hence, the complaint.



3. This court had earlier granted anticipatory bail to the petitioner Crl.O.P.No.5470 of 2021 by imposing certain conditions. However, the petitioner without complying the conditions and filing of sureties, no case arises for had filed this anticipatory bail application.

4. In view of the above position no case arises for grant of fresh anticipatory bail and this petition is disposed of and time is extended by a period of two weeks from the date of receipt of copy of this order for complying the conditions imposed in Crl.O.P.No. 5470 of 2021.
