4. It is seen that the offence committed by the accused is grievous in nature and the learned trial Court on considering the oral and documentary evidence has convicted the accused.

5. Therefore, considering the nature of the offence and the age of the victim girl, this Court is not inclined to suspend the sentence and inclined to hear the appeal itself.

6. In view of the same, this Miscellaneous Petition is dismissed. Registry is directed to list the criminal appeal on 04.03.2021, for final disposal.
