PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest for the alleged offences punishable under Section 8(c) r/w 20(b)(ii)(B) of NDPS Act in Crime No.625 of 2021, on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that the petitioner along with other accused person were found in illegal possession of 2.650 kgs. of Ganja and the same was seized by the respondent police.

3. The learned counsel for the petitioner submitted that the petitioner is an innocent person and she has been falsely implicated in this case. Hence, he prays to grant anticipatory bail to the petitioner.

4. The learned Government Advocate submitted that the petitioner along with other accused person were found in possession of 2.650 kgs. of Ganja. He further submitted that this is the second anticipatory bail application filed by the petitioner and this Court has already dismissed the earlier anticipatory bail application of the petitioner in Crl.O.P.No.14827 of 2021 dated 19.08.2021. Hence he opposed to grant anticipatory bail to the petitioner.



5. Considering the gravity of offence and the earlier anticipatory bail petition was dismissed by this Court and there is no change of circumstances, this Court is not inclined to grant anticipatory bail to the petitioner.

6. Accordingly, this Criminal Original Petition is dismissed.
