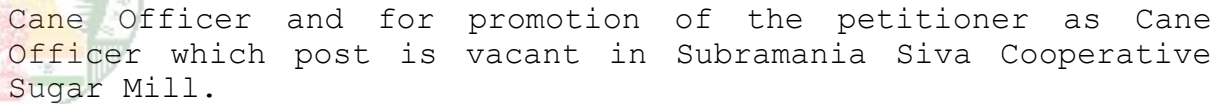

The prayer sought for in the writ petition is to direct the 1st respondent to dispose of the representation of the petitioner dated 22.09.2021 based on the recommendations of the Commissioner of Sugar / 2nd respondent herein and that of the Managing Director / 3rd respondent herein to relax the Educational Qualification of B.Sc., (Agri) for the post of

5. Per contra, the learned Special Government Pleader appearing for the respondents 1 & 2 has submitted that the Government in G.O.Ms.No.132, Industries (MIC-2) Department, dated 10.11.2018 and G.O.Ms.No. 87, Industries (MIC-2) Department, dated 27.03.2019, have clearly mentioned that the qualification for the post of Cane Officer is Bsc (Agri) with three years experience as Cane Assistants/Cane Development Assistants in Cooperative Sugar Mills. Whereas the petitioner herein has possessed the qualification of Diploma in



Agriculture B.Sc (Botany), therefore, the petitioner is not eligible for the said post.

6. The prayer in the writ petition is only for a direction to consider the petitioner's representation dated 22.09.2021 based on the recommendation made by the 2nd respondent.

7. In view of the limited prayer sought for in the writ petition, without expressing any opinion on merits of the case, I direct the 1st respondent to consider the petitioner's representation dated 22.09.2021 by taking note of the recommendation made by the 2nd respondent and to pass orders in accordance with law, as expeditiously as possible, within a period of twelve (12) weeks from the date of receipt of a copy of this order.

8. With the above directions, the writ petition stands disposed of. No costs.
