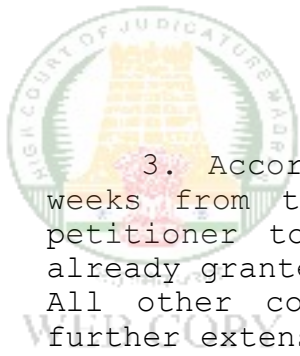

Vide Order dated 10.08.2021 in Crl.MP.No.7555 of 2021, this Court had granted six weeks time to the petitioner to comply with the conditions imposed on 16.02.2021. This petition has been filed by the petitioner seeking further extension of time to comply with the conditions.

2. Being satisfied with the reasons shown in the affidavit filed in support of the petition, the prayer sought for by the petitioner deserves to be considered favourably.

Accordingly, time is extended by a further period of four weeks from the date of receipt of a copy of this order for the petitioner to comply with the conditions, failing which, the bail already granted to the petitioner shall stand automatically cancelled. All other conditions remain unaltered. It is made clear that no further extension will be granted.
