2. The learned Senior Counsel for the petitioner has also filed a copy of the legal heir certificate issued by the Tahsildar dated 06.09.2021. It is submitted that despite the fact that the petitioner has produced the above records, the respondents have not sanctioned pension till date. It is noticed that the petitioner has sent representation to the respondents along with enclosures on 15.09.2021.

Considering the fact that the petitioner is aged about 71 years as per the legal heir certificate dated 06.09.2021, this writ petition is disposed by directing the respondents to consider the representation of the petitioner's dated 15.09.2021 and pass appropriate orders within a period of 45 days from the date of receipt of a copy of this order.
