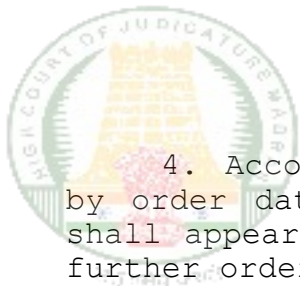

4. Accordingly, the condition insofar as appearance as imposed by order dated 23.09.2021 alone stands modified and the petitioner shall appear before the respondent Police as and when required until further orders. All other conditions remain unaltered.
