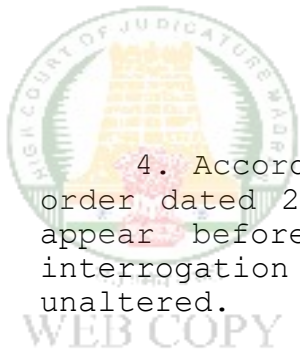

4. Accordingly, the condition insofar as appearance as imposed by order dated 22.09.2021 alone stands relaxed and the petitioner shall appear before the respondent police as and when required for interrogation on receipt of summons. All other conditions remain unaltered.
