4. Considering the facts and circumstances of the case, the condition already imposed on the petitioner in Crl.O.P.No.16725 of 2020 dated 20.11.2020, is relaxed, however the petitioner is directed to appear before the respondent police as and when required.

5. This petition is ordered accordingly.
