Vide order dated 20.05.2021, this Court had enlarged the petitioner on bail on certain conditions. This petition has been filed by the petitioner seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondents, on instruction, submits that the petitioner has not been complying with the conditions regularly. He further submitted that there are three previous cases pending against the petitioner.

3. In view of the above submissions, this Court is of the considered view that the prayer as sought for by the petitioner could not be acceded to.



4. Accordingly, this miscellaneous petition stands dismissed.
