(i) Calling for the records of the 1st respondent in Pa.Ma.Ma.No.205/2018/A2 dated 12/02/2019 and quash the proceedings of the 1st respondent dated 12/02/2019 and consequently direct the 1st respondent herein to restore the name of T.N.Thangarathna Theetchidar in the Property Tax Register No.092/019/00280 (Old No.8950) in respect of the property bearing door No.134/54, East Car Street, Chidmabaram (in WP.No.20437 of 2020) and;

(ii) Calling for the records of the 1st respondent in Pa.Ma.Ma.No.092/001/1/18-19/0004656 dated 12/02/2019 and quash the proceedings of the 1st respondent dated 12/02/2019 and consequently direct the 1st respondent herein to restore the name of T.N.Thangarathna Theetchidar in the Water Connection No.092/019/00044 (Old No.8049) in respect of the property bearing door No.134/54, East Car Street, Chidmabaram (in WP.No.20440 of 2020).
