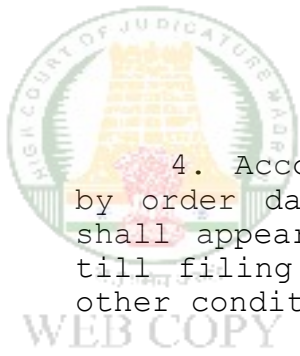

4. Accordingly, the condition insofar as appearance as imposed by order dated 17.09.2021 alone stands modified and the petitioner shall appear before the respondent police every Monday at 10.30 a.m till filing charge sheet and thereafter as and when required. All other conditions remain unaltered.
