Vide order dated 20.09.2021, this Court had enlarged the petitioners on bail on certain conditions. This petition has been filed by the petitioners seeking relaxation of the conditions.

2. Learned Government Advocate (Crl.Side) appearing for the respondent, on instruction, submits that the petitioners have been complying with the conditions without fail. He further submitted that the charge sheet has been filed.



3. In view of the above submission, this Court is of the considered view that the prayer as sought for by the petitioners could be acceded to.

4. Accordingly, the condition insofar as appearance as imposed by order dated 20.09.2021 alone stands relaxed and the petitioners shall appear before the respondent police as and when required for interrogation and before the trial court on each and every hearing date. All other conditions remain unaltered.
